**ORDINANCE NO. TO 2024-18**

**AN ORDINANCE AUTHORIZING THE LEVY AND COLLECTION OF TAXES FOR  
WESTDALE PARK DISTRICT FOR THE 2024 TAX YEAR**

---

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF LEYDEN, COOK COUNTY, ILLINOIS, as follows:

**SECTION 1:** The total amount of money deemed necessary by the Board of Trustees of the Town of Leyden, as successor by merger to the Board of Park Commissioners of Westdale Park District pursuant to 5 ILCS 220/3.6, to be raised, levied and collected from the tax levy of the current year for park purposes pursuant to the merger of Westdale Park District, is hereby ascertained to be the sum of One Hundred Thirty Thousand, Eight Hundred One Dollars and 00/100 Cents (\$130,801.00) for the 2024 tax year.

**SECTION 2:** The total sum of One Hundred Thirty Thousand, Eight Hundred One Dollars and 00/100 Cents (\$130,801.00), being the amount deemed necessary for collection from the 2024 Tax Levy for the area comprising the territory of the former Westdale Park District for park purposes pursuant to the merger of Westdale Park District by the Town of Leyden, to provide for the General Park Fund, be and the same is hereby levied upon all of the taxable property in the area comprising Westdale Park District for the 2024 tax year in the specific amounts set forth herein for the following objects and purposes:

**SECTION 3:** The total amount of One Hundred Thirty Thousand, Eight Hundred One Dollars and 00/100 Cents (\$130,801.00), ascertained as aforesaid, be and the same is hereby levied and assessed pursuant to 5 ILCS 220/3.6 within the area comprising the territory of the former Westdale Park District, according to the value of the same as assessed and equalized for State and County purposes for the current year.

**SECTION 4:** The Board of Trustees of Leyden Township does hereby certify to the County Clerk of Cook County, Illinois, the several sums aforesaid, constituting said total amount of One Hundred Thirty Thousand, Eight Hundred One Dollars and 00/100 Cents (\$130,801.00) which the said Town of Leyden requires to be raised by taxation in the 2024 tax year for park purposes of the Township for the area comprising the territory of the former Westdale Park District, and the Town Clerk is hereby authorized and directed to file a certified copy of this ordinance with the County Clerk within the time provided by law.


**SECTION 5:** This Ordinance shall be in full force and effect from and after its passage as provided by law.


